

IN THE CRIME PREVENTION EFFORTS THAT WE UNDERTAKE

We employ three approaches, namely: Increasing Perceived Efforts (how to enhance the perception that committing a crime will require significant effort, with the use of access control, for example), Increasing Perceived Risk (how to heighten the perceived risk felt by potential criminals, such as installing CCTV, alarms, or conducting checks by guards), and Reducing Anticipated Rewards (how to diminish or make it challenging for potential criminals to gain benefits from committing crimes, such as securing valuables with the use of safes, etc.).

Moreover, as the core support for crime prevention, we incorporate Risk Assessment, Security Training, and Information Security.


All security incidents are recorded and owned entirely by the client. Yearly data series provide security incident trends for continuous improvement annually.
